Important Information:

Seats & Bedding: The *Clearwater/St. Petersburg Ski & Sports Club* will make every effort to accommodate requests for airline seating & lodging bedding configuration. However, we **cannot** guarantee any particular seats or bedding arrangements.

Changes: Travelers making any changes in air reservations, lodging or lift tickets etc, **AFTER** any applicable deadline dates will incur any charges made by the supplier.

Airlines: The *Clearwater/St. Petersburg Ski & Sports Club* is not responsible for airline schedule changes and/or change of airlines.

Frequent Flyer: It is the travelers' responsibility to ensure the credit of any frequent flyer mileage to their personal account. This is best done at airline check-in.

Trip Prices: Travelers are subject to any new taxes or fees imposed by either the government, airline, lodging or any agency involved.

Smoking: All airlines and transportation are Non Smoking. Smoking **MAY** be available in certain lodgings. Traveler must contact the trip leader to see if it is available.

Trip Cancellation Policy

1. Cancellation by a traveler prior to the cancellation date specified on the official trip description will result in a \$50 cancellation fee.
2. Cancellations after the cancellation date shall result in the total cost of the trip as determined by the Club. The traveler may obtain a substitute for their travel slot but shall be responsible for any charges incurred due to name changes and or cancellations.
3. Cancellations must be submitted in writing to both the trip leader and the clubs VP of Trips.
4. All trip payments are due on the date specified on the official trip description. If payment is not received when specified, the traveler risks losing their place on the trip.
