**Changes:** Travelers making any changes in air reservations, lodging or lift tickets etc, **AFTER** any applicable deadline dates will incur any charges made by the supplier.

**Airlines:** The *Clearwater/St. Petersburg Ski & Sports Club* is not responsible for airline schedule changes and/or change of airlines.

**Frequent Flyer:** It is the travelers' responsibility to ensure the credit of any frequent flyer mileage to their personal account. This is best done at airline check-in.

**Trip Prices:** Travelers are subject to any new taxes or fees imposed by either the government, airline, lodging or any agency involved.

## Trip Cancellation Policy

2. Cancellations after the cancellation date shall result in the total cost of the trip as determined by the Club. The traveler may obtain a substitute for their travel slot but shall be responsible for any charges incurred due to name changes and or cancellations.
